Also consider residency requirements. This committee will operate independently of the disciplinary thesis committee. Select a style manual. Review current graduate policies for additions, clarifications, etc.

	 Two Master's programs coming forward this year need thesis and graduate assistants. Currently we have not established policies for graduate assistants and theses. If we can develop them by December, we can send through policy process in the Spring to be in place by Fall 2019. Provost asked this committee to create the policy. We have some samples from other universities. Definition of Thesis needs to be defined including: approval process, how many on advisory committee, what will the institutional level process involve, how does that process use the graduate council, etc. Adopt a Thesis Booklet, use one already established that will work for our institution, include style manual Sub-committee for Thesis Definition and policy: Mark Jeffreys, Geoff Smith and Travis Ficklin Sub-committee for Policy for Grad Assistantships: Jared Dupree, Lish Harris, and Kathryn Syssoyeva Use USHE institution policies as a base to create policy. Policies need to define up front what items mean. Use template in Policy Library to format new policies. Address residency requirements vs online delivery, generally address how money will be provided leaving programs the responsibility to cover costs. Need to use HR and Budget to help. Could use different levels of tuition waiver.

MA Technical Writing and Digital Rhetoric	A	M: Travis Ficklin S: Lish Harris Motion: Ready Proposal	Approved, Unanimous	Cheri Crenshaw (Interim Dean for College of Humanities), Mike Peterson (Interim Chair of English Department): Proposing a Master's degree in writing specifically for anything with an electronic submission. Graduate students with skills in writing apply through application writing sample submission process. The degree offers technological expertise, with a 30-credit requirement. It includes three options for culminating experience: thesis, internship, or Master's portfolio. Graduate teaching assistant program allows graduate students to teach composition classes. Pay for assistants will be same as adjuncts. \$3000 per class. Teach 2 classes. Graduate Tuition will charge \$300 per credit hour with 3 classes per semester. 1st year the department will stretch for funding and then will start to make money that goes to academic programs. • Will there be different charge for out of state? In state is \$300 per credit hour, out of state should be different. • Is the cost comparable to other programs in the state? Comparables for tuition already done by Bryant Flake. Lower than anywhere else in the state.

New equipment allows for an "Owl" that moves in the room to be a combination for electronic access. Only need two or three composition instructors so we won't lose graduate assistants to online delivery.
- Credits similar to other program in the state. Do we have faculty that can teach already? Anyone specializing in technical writing? Yes, faculty already able to teach the graduate level courses.
- The market is growing for employment in this area.
- Do you see that students with different backgrounds than English could apply? Students that come with writing skills should be eligible. GC recommends change the requirement to open to other students to encourage any variety of qualified student. Require proctored writing sample to vet eligible students.
- Program is full time 2 years online or evening delivery targeting working professions. Are other competitive programs 2 years? Program requires 30 credits, professional people. If demand could offer summer courses.
- Special Topics change the subtitle each time.
- Recommendation to review the PLOs to put in DSU standardized format.
- Research and Development team and launch team for new programs will work to make sure students don't drop through the cracks and make sure the program is well communicated/advertised.
- As a university could we pull expertise from other departments to offer more integration into programs offered at DSU. More programs working in that direction.

Master of Athletic Training (MAT)	A	M: Mark Jeffreys S: Lish Harris Motion: Ready Proposal	Approved, For: 4 Abstain: 1	Travis Ficklin, Eli Bermudez (Dean of College of Health Sciences), Susan Hart (Chair Health & Human Performance Department): This program is Accredited by an outside governing body. Commission on Accreditation of Athletic Training Education (CAATE). It is a 60 credit program to be done in 2 years. By CAATE's standards we don't currently have faculty qualified and will need to hire 2 new faculty: Program Director and Education Coordinator. We are allowed to start without accreditation as long as accredited before students graduate. Peter Neibert has prepared this application as a consultant and expert for CATTE. Differential Tuition will be \$340/credit hour for residents and \$850/credit hour for out of state. We believe that a successful 1st cohort will be 10 students. After 2 years we will actually make money on the program. Also will need additional faculty after 3 years. Research on the demand for the program: SUU approved a MAT program and currently say they are accepting application but have not applied for accreditation yet. The need is still valid within our university and the demand across the State with both programs. Our program requires a slightly lower GPA requirement to collect students not allowed in other programs. New facility in the Human Performance Center already developing for space for the program. Currently athletics uses athletic trainers from IHC. Our program could increase use of internal athletic trainers. Requirements from CAATE to get accreditation include submitting self-study and site visit these costs are included in differential tuition. We must be accredited to gradate athletic trainers. By 2022 all athletic trainers must have a graduate degree. Other faculty can teach in the program. Just need the 2 qualified and then others can teach.

New Course Proposals (Course specif				 Will establish minimum cohort to make sure that students can finish with the faculty that we have. GRE scores do they really need it? We do need a limiting factor to admissions. Culturally, will it be seen as less a program? Need to decide to use GRE with limit or eliminate it or an equation on how to weight application factors. Research as to whether GRE is an indicator of whether students will pass licensing exam and/or to find solid data predictive to pass the GRE to get a strong cohort. Program lean towards leaving the standardized test. Recommend as the program moves forward in the approval process to establish an actual scale for the application of the GRE test to admit into the program. Report of survey to just students at Dixie State University. 95 responses 67 interested in MAT and the vast majority of those indicated that If that program is here, they would be highly interested in staying at this university. Are there clinical hours required? Clincial hours are part of the course work in the program. This program has interprofessional development here in DSU with the whole College of Health Sciences which isn't part of the SUU program. Will student attend in the summer: Yes, FA 12 credits, SP 12 credits, SU 6 credit schedule, full-time, face-to-face, onsight clinical experience. Tuition lower than other programs in the state. Competitive pricing. Non-resident tuition is competitive with other in state programs. Huntsman senior games, club tournaments, all high school activities will require MATs.
